1) Fill this contract on-screen 2) SAVE it on your computer, 3) then email us that newly Saved file!

-OR- Print, hand write, then scan & email that to us: info@beachpeopleweddings.com

1. First, you send Margo an email or call to confirm availability for your date/time/location, and to answer your questions:
EMAIL: info@beachpeopleweddings.com PHONE: 336-314-0503
2. **7-DAY- HOLD** – Then, she REPLIES TO CONFIRM holding your date/time for 7 days while waiting for your retainer and contract to arrive. On the 8th day she must re-open your date for other interested couples, unless you contact us for an extension before Day7 & no one else is waiting.
3. Next, email the Retainer and Contract (pages below --EITHER, fill it on-screen, save to your computer, then email us that New Saved file; OR print/write/then scan/email them to Margo) **Email: info@beachpeopleweddings.com**
4. **RETAINER:** All taxes are included in all fees! (see PAGE 2 for retainer amount). Please use one of these 6 options:
 - **CASH** – is preferred but if you are sending from a long distance, we have other options, of course.
 - **CREDIT/ DEBIT CARD** – online only. Accepting Visa, M/C, Discover, Diners Club, JCB or American Express. Email us to get the required info and link: info@beachpeopleweddings.com
 - **MONEY ORDER or CASHIER'S CHECK** – Made Payable to: Margo Ross Sears
No personal checks, please – she will return personal checks to you (b/c bank holds out-of-town checks and fines us heavily for bounced ones). Send a money order or cashier's check instead, please. U.S. Post Office sells them cheaply.
 - **PAYPAL** – a last resort, please! They are costly. IF used, send to: info@beachpeopleweddings.com
 - The Retainer amount is deducted from your Total. However, the Retainer amount is non-refundable, but if you cancel or re-schedule, the Retainer becomes a credit with us (see #11 here).
 - **BALANCE** is due on the shooting date before we start, or sooner if you wish.
5. **TRAVEL FEE: NO travel fee for Ocean Isle Beach NC, Sunset Beach NC, Cherry Grove SC, North Myrtle Beach SC!**
She serves over 75 beaches and cities year-round. Fee is for each roundtrip:
 - Holden Beach NC, Oak Island NC, Southport NC, Caswell Beach NC = \$25
 - Wilmington NC, Wrightsville NC, Myrtle Beach SC, Surfside SC, Garden City SC = \$50 (2-3 hours roundtrip)
 - Carolina Beach NC, Kure Beach NC, Topsail NC, Murrells Inlet SC, Huntington State Park = \$100 (a 3-4 hours roundtrip)
 - Surf City NC, Emerald Isle NC, Litchfield SC, Pawley's Island SC, Georgetown SC=\$200 (4-6 hours roundtrip AND perks with this price at no charge: full artistic editing plus 2 extra complete flashdrive copies to share)
6. **LATE START Policy: BE ON TIME! This is VERY important! Start everyone ON TIME.** A late start can have MANY bad effects with weather, elderly guests, available lighting dims, melting cakes, restaurant reservations, AND impacts our other weddings. **Except for weather delays**, a late fee of \$50 cash immediately-in-hand for every 15 minutes you don't begin the ceremony after your scheduled start-time, and may be charged at our discretion. Please **emphasize to all guests and relatives to be ON SITE 15 MINUTES AHEAD. BE ON TIME!**
7. **Please make every effort to know your location in advance.** Late arrivals to an outdoor wedding have adverse effects, plus cause delays to our other weddings that day. Therefore, our Late Arrival Policy (#6 above) is important to know.
8. **RAIN: we do not provide rain back-up locations.** That is your responsibility for your outdoor wedding (but we can help with ideas sometimes). Downpour rain is rare in summer in this geographical location; please see our [Weather & Rain Advice to manage this better, HERE.](#)
9. Usually, Margo starts shooting just minutes prior to start time, all throughout the ceremony, then your choices of group shots and family shots afterward, then a series of romantic portrait wedding poses at the end. Happy to change this to include pre-wedding shots and adjust the time for it. Consider adding more time to the shoot for a fee, see Add-Ons for Additional Shooting Time.
10. **CANCELLATION / RESCHEDULE Policy:** First reschedule is free, subsequent reschedules are \$100/each. Retainer is non-refundable. Monies over the retainer amount will be refunded asap. Retainer becomes a non-transferable credit to the payee within 60 months (5 years) from cancellation date: we serve over 100 locations, in 2 states, and offer beach photography and senior portraits too.
11. **NEXT: Once Margo gets your retainer and contract (see 1-5 above), she countersigns it, marks retainer paid, emails copy back to you, along with next-steps instructions.**

THIS IS A LEGAL and BINDING CONTRACT. The clients, signed below, understand that they must adhere to the date and time listed above, but client may change them at the Photographer's sole discretion if schedule permits.

Should the photo session begin later than scheduled due to issues beyond the control of the Photographer, Clients agree that the contents of the photo session may be spontaneously edited for time, as needed, solely at the discretion of the Photographer.

Your Photographer will leave ample time to allow for the unforeseen, and will do everything possible to accommodate extenuating circumstances. In the event the scheduled Photographer is prohibited from attending the photo session as planned due to hospitalization, auto accident, hurricane, dangerous weather other unforeseen cause of non-arrival on the day of the photo session, David Sears and Margo Sears will make every attempt to provide a substitute Photographer who provides substantially the same type of service, and notify couple or family. In any event, BeachPeople Weddings, LEWA, David Sears, Margo Sears, and their agents shall not be held liable for any compensation or damages due to non-performance of any photo session/function resulting from such incapacitation, non-arrival, late arrival, or errors of any type.

Photographer is not responsible for the cost of any optional props or equipment or supplies clients want for the photo session. Retainer amount is non-refundable but becomes a credit for 60 months (5 years) from date of cancellation, not from the booking date. Photographer double checks every USB flashdrive for perfect performance, before shipping and puts tracking on the package. Once it is shipped out of her hands, Margo is not responsible for any damage from mishandling by others. Replacements may be purchased from Photographer.

CANCELLATION/ RESCHEDULE Policy: First reschedule is free, subsequent reschedules are \$100/each. Retainer is non-refundable. Monies over the retainer amount will be refunded asap. Retainer becomes a non-transferable credit to the payee within 60 months (5 years) from cancellation date: fyi--we serve over 100 locations and offer beach photography and wedding packages too.

You will be issued limited, lifetime printing rights only in a detailed letter mailed WITH images. Photographer retains ownership of all photos, per standard practices of federal Copyright Law. Note: **USB flashdrives are very sturdy and the photo files are closely double checked before shipping in bubble-wrap by First Class mail with tracking #. Although VERY rare to occur, once it ships, the photographer cannot be responsible for mishandled or damaged condition of USB Flashdrive.** Replacement or extra copies may be ordered from Margo for a small fee.
